GovNET currently has towers available for collocation space, but no equipment shelters yet installed on the sites prior to suspension. The amount of available space varies per backbone or node location. GovNET has conducted a significant amount of public outreach to develop partnerships for interconnection. Other network providers will be able to interconnect through almost every tower, monopole and roof mount installed as Community Interconnect Points in the rural communities included in the network.
