Average cost per new mile (Middle Mile)	0	While the proposals for the second procurement were being evaluated, HR 3630 was signed into law by President Obama. It mandates public agencies to vacate the T-Band spectrum which had been the cornerstone of the LA-RICS system design. After evaluating different options and deciding on a hybrid system to comply with the new law, the LA-RICS Authority Board decided to cancel the second procurement. A decision was also made to conduct separate procurements for telecom contractors for the Long Term Evolution (LTE) and the Land Mobile Radio (LMR) systems. On October 25, 2012, the RFP for the LMR system was released. Proposals are being evaluated and a contract is expected to be executed by June, 2013. By mid February, 2013, the RFP for the LTE system should be substantially complete pending decision by FirstNet and instructions from NITA.
