Project Title and Project Description

Project Title: Beacon 2.0

Project Description: OSHEAN's Beacon 2.0 project will deliver a middle mile infrastructure to provide substantially upgraded and affordable broadband connections using a dedicated fiber optic network. The project will serve the unmet Broadband capacity needs of our Community Anchor Institutions (CAI), including higher education, health care, and government organizations, in Rhode Island and Southeast Massachusetts.

- expand capacity to offer public-use PCs
- enable expanded employment training and workshops
- provide streaming video equipment to promote regional access to state wide education programs; and, to allow libraries to offer classes in one location and allow the content to be shared at any public library.

OSHEAN works closely with OSL, a non-profit organization with 49 member libraries that provides the public with over 6.9 million items borrowed per year. It has a membership of over 520,000 registered library card holders. Nearly all RI residents have access to an OSL library in their own communities.

Synergies:

If awarded, this Beacon 2.0 Middle Mile project will use fiber optic networks to expand the State's broadband capacity and enable affordable service to CAIs in all five RI counties including the 49 libraries that will benefit from our recently awarded grant for Beacon 2.0 LCC.

Our libraries have become the primary locations for accessing online resources for many Rhode Islanders as they are forced to give up their home broadband connections during this recession. They provide laid-off/displaced workers with essential services including online job searches, on line job applications, and basic Internet training.

The awarded Beacon 2.0 LCC project is designed to enable OSL to set up permanent workstations at all of its libraries plus 10 state-of-the-art mobile computer centers, geographically dispersed and located in Rhode Island communities that are the most underserved and have higher rates of poverty. These centers will allow us to offer streaming video shared among libraries. Videoconferencing between OSL and the member libraries will be used for instruction, workshops, conferences, etc. For libraries like Island Free Library on Block Island, staff would likely increase their attendance from what is less than 20% of all OSL meetings and workshops to close to 100%.

Creating affordable connectivity for these libraries is essential to achieve the synergies we have planned, especially for distance learning applications. OSHEAN's proposed Beacon 2.0 middle mile project will provide that affordable, sustainable, and substantially upgraded access to

Executive Summary of the proposed project:

BROADBAND NEEDS OF OUR ANCHOR INSTITUTIONS AND AN OPPORTUNITY

Rhode Island and South Coast, Massachusetts' non-profit CAIs have significant, unmet needs for broadband capacity. Commercial access simply does not meet their heavy demands. CAIs need a minimum of 1 GigE for basic functions and several are seeking up to 10 GigE for advanced applications. Unfortunately this amount of capacity is usually not affordable and, in some cases, not available.

Founded in 1999, OSHEAN is a non-profit consortium and collaborator between private enterprise, government, and many CAIs including universities, community colleges, libraries, schools, hospitals, state police and emergency responders. With Beacon 2.0, OSHEAN is positioned to help boost Rhode Island out of its recession and to implement an important program that will benefit the state's most vulnerable citizens. Our existing broadband service, Beacon 1.0, delivers broadband capability to our member CAIs utilizing dark fiber at affordable rates. The Beacon 2.0 infrastructure will leverage this infrastructure and will reach all Rhode Island counties and parts of South Coast, Massachusetts.

The Beacon 2.0 project will offer substantially upgraded connections to 20 significant anchor institution partners representing 50 facilities. It will also provide middle mile fiber that passes approximately 349,000 households, 9,000 businesses, and nearly 500 CAIs including hospitals, community colleges, universities, non-profit research organizations, nursing homes, community health centers, public libraries, firehouses, police stations, over 70 K-12 schools, and the Narragansett Indian Tribe. Beyond the 20 institutions that have already committed, we expect to add other new subscribers and have provided a conservative estimate of 14 additional institutional subscribers in our pro-forma projections.

Rhode Island has one of the nation's highest unemployment rates (12.9%). Four of the state's five counties are classified as distressed by the Bureau of Economic Analysis and the Bureau of Labor Statistics. In addition to helping the anchor institutions that help our citizens, OSHEAN estimates that Beacon 2.0 will create 337 job-years, which consist of 160 direct job-years, 56 indirect job-years, and 121 induced job-years.

AN ACTIVE PARTNERSHIP WITH THE COMMUNITY

All of the anchor institutions to be passed by the Beacon 2.0 Network will now be able to obtain enhanced broadband service of 1 GigE to 10 GigE at rates significantly below those offered by commercial providers. The following CAIs are partnered with OSHEAN and all have signed letters of commitment to provide their own funding to connect to the Beacon 2.0 Network. They include:

SYSTEM OVERVIEW AND AFFORDABLE, SUSTAINABLE SERVICES TO BE OFFERED

OSHEAN will leverage existing dark fiber assets and, where needed, build new fiber to provide the affordable advanced optical infrastructure that our CAIs need. When compared to current commercial rates, Beacon 2.0 will save subscribers at 1 GigE point-to-point levels. CAIs requiring very high capacity will benefit by our 10 GigE capacity offering, a service that is not commercially available to many of these institutions.

Our solution also serves to "future-proof" our CAIs. OSHEAN services will initially include broadband access at the 1 and 10 GigE capacities but will be scalable to 100 GigE, which is sure to be required by some CAIs within 8 years. We chose a 48-strand fiber build because a lesser amount would become insufficient within 5 years. Finally, our use of fiber optic networks will allow our CAIs to take advantage of future data exchange technologies that have not yet been commercialized, such as those beyond IP.

OSHEAN will continue to provide full network management services, 24x7x365, all with industry standard service levels appropriate to the mission critical nature of our subscribers' enterprise systems.

OSHEAN will abide by the FCC's non-discrimination and network interconnection obligations, specifically FCC's Broadband Policy Statement 05-151. To encourage broadband deployment and preserve and promote the open and interconnected nature of the public Internet, all OSHEAN institutional subscribers will be entitled to access the lawful Internet content, run applications, and use services of their choice. Subscribers will also be able to connect their choice of legal devices that do not harm the network.

OSHEAN has a record of success in implementing similar projects as a non-profit broadband service provider, having operated a fiber-based layer 3 ISP network for the last 10 years. Over that time the network has grown to a multi gigabit capacity network. To take advantage of favorable pricing from upstream ISPs in Boston, OSHEAN developed strategic agreements with dark fiber providers for low cost transport. Since then, OSHEAN has been steadily connecting 14 CAIs and 35 facilities at an average growth rate of 15% per year. OSHEAN also holds a maintenance contract on the Level 3 Rhode Island State Fiber. The Core Network Team was also responsible for the network design and maintenance of the NEREN Optical network which connects New England's most prestigious educational institutions.

OVER 30% MATCHING FUNDS

OSHEAN is requesting \$22,169,183 in this application. We will receive matching funds from our partners totaling \$11,396,558 (\$10,434,857 of which is cash), which represents 34% of the grant request. CAIs and Partners provided Letters of Commitment delineating matching funds.

Project purpose:

A – Problem/Opportunity

Rhode Island and South Coast, Massachusetts's non-profit CAIs have the greatest community needs for advanced broadband capacity, yet they have limited resources to pay for a solution. In many areas, access to dark fiber is simply unavailable and existing commercial line access does not meet their heavy demands. CAIs require a minimum of 1GigE in order to communicate with each other, their constituents and the Internet at-large. Several are seeking up to 10GigE for advanced applications. Through Beacon 2.0, OSHEAN will provide the opportunity to deliver higher bandwidth and affordable broadband solutions to those anchor institutions that do not have access to dark fiber today.

B – Effective Solution

Beacon 2.0 will create a 357 mile fiber network that will substantially upgrade connections to 20 CAIs and 50 facilities and will also pass hundreds of potential CAIs. For ten years, OSHEAN has been building a communications infrastructure to serve the needs of RI and MA institutions of higher education, state and federal government agencies, non-profit research organizations, public libraries, schools, workforce development and economic development efforts. OSHEAN will leverage existing dark fiber assets and build new fiber to provide the economical, advanced optical infrastructure needed.

Our solution also serves to "future-proof" our CAIs by making our infrastructure scalable to 100 GigE, by using 48-strand fiber, and by using a fiber optic solution that will allow our CAIs to take advantage of future data exchange technologies that have not yet been commercialized.

C – Broad Significance and Opportunities to Replicate

Beacon 2.0 will have a wide scale effect on RI and South Coast, MA. It will pass 500 institutions and points of interest and provide an affordable option for broadband access between 1 GigE and 10 GigE. Beacon 2.0 will have an immediate impact on 50 CAI facilities. Synergies with our successful Round 1 application (Beacon 2.0 Library Computer Center, Grant # 346) will allow our Beacon 2.0 middle mile project to provide affordable, sustainable, and substantially upgraded access to Libraries. This will allow the libraries to provide distance learning, completion of patron online job applications, and virtual library meeting attendance for library staff. The equipment for this capability was awarded in the Round 1 grant, however the affordable broadband connectivity can only be realized buy the proposed Beacon 2.0 network.

D – Unserved/Underserved Area

Beacon 2.0 will provide middle mile capacity within underserved areas. OSHEAN has developed partnerships with organizations that will bring connectivity to South Coast, MA, Narragansett Indian Tribe, and Block Island. OSHEAN will work with our member RINET to bring service to the school, library, hospital and town hall on Block Island. We will seek a service provider to offer last mile wireless services in western Rhode Island.

Beacon 2.0 will support educational institutions, public libraries, hospitals and other health care organizations, and other community support organizations. In summary:

Education – OSHEAN will provide enhanced capabilities, such as distance learning, to the community and technical colleges that are the backbone of technical career training and the reeducation of our workforce. Beacon 2.0 will bolster the strong life science research engine that exists between our research universities and our leading hospitals, by creating 10GigE connections to shared supercomputing facilities. Beacon 2.0 will pass over 70 K-12 schools making more capacity and access options available to them.

Health – OSHEAN will provide the capacity for the collaboration of our research hospitals and universities. Digital diagnostic images and medical records systems will be sharable among partner hospitals. Over \$11M in ARRA HITECH funds will be leveraged to connect 9 health care organizations to the State's Care Health Inform Exchange (HIE).

Government – OSHEAN will provide economical broadband access to one of RI's largest government campuses of state agencies; including the Departments of Labor and Training, Health, and Transportation as well as increase public access to records at Rhode Island's underserved courthouses.

Outreach to Vulnerable Populations – Beacon 2.0 will enable distance learning and streaming of employment assistance at 49 public libraries. Two community health centers located in the two largest urban areas will be expanded to deliver health services to the most vulnerable populations in the state. We will connect healthcare and educational facilities at the Narragansett Indian Tribe.

E. 4: Public Safety

We will build dark fiber to 2 State Police and the newly build RI State Police headquarters which houses the statewide E911 system. We will provide dark fiber to the Providence's public safety wireless network that supports the city's police and fire departments. We will leverage Federal Homeland Security grants that provide security cameras for vital infrastructure such bridges and the Port of Providence. We will provide support for the RI Disaster Medical Assistance Team,

which was recently honored by the U.S. Department of Health for its model program to administer H1N1 vaccinations.

E. 5: Job Creation

Beacon 2.0 will create 364 job-years. Beacon 2.0 will also provide the ultra-broadband 10GigE connections that our research hospitals and universities need to conduct the bio-research that will serve as a catalyst for job creation by spinning-off the entrepreneurial firms in life sciences and medical device manufacturing that will be the cornerstone of RI's knowledge economy.

Recovery Act and Other Governmental Collaboration:

OSHEAN has planned this project in close cooperation and collaboration with governmental bodies and other important institutions in the community. We will also leverage two American Recovery and Reinvestment Act (ARRA) grants for health information technology (HIT).

Leverage other ARRA Grants

The Rhode Island Quality Institute (RIQI) received \$11.28 million from two American Recovery and Reinvestment Act (ARRA) grants for health information technology (HIT). This investment will help create jobs and allow hospitals and providers throughout the state to upgrade their technology systems and improve patient care while controlling costs and reducing medical errors. The RIQI is a national leader in health IT. Their work has demonstrated that evidence-based outcome measures can reduce medical errors, provide better preventative care, improve the quality of care, and reduce costs. Specifically, RIQI has received two separate grants:

- 1. Health Information Exchange Award \$5,280,000: this funding will assist RIQI in implementing an integrated information exchange to improve health outcomes, reduce medical errors, and make our health care delivery system more effective and efficient.
- 2. Regional Extension Center Award \$6,000,000: much like agricultural extension services aid farmers in growing crops, HIT regional extension centers will assist health care providers in integrating effective HIT systems. This funding will allow RIQI to provide such vital technical assistance to doctors, hospitals, and other health care providers.

Beacon 2.0 will create substantial project efficiencies with the RIQI's efforts through the use of the Beacon 2.0 network to provide connectivity from Rhode Island hospitals to a central data center. The data center, which is currently connected to the OSHEAN network, will provide the hub by which all data is distributed to stakeholders.

Beacon 2.0 will leverage the construction of a fiber network by the University of Rhode Island which utilizes federal grants from the Dept of Energy, National Science Foundation, and National Institutes of Health for a total of \$2.6M. This collaboration will provide greater efficiencies by allowing URI to utilize the Beacon 2.0 Network to extend its reach.

We will leverage the RI EMA Urban Area Security Initiative federal homeland security grants in the amount \$4.5M, to provide connectivity from security cameras that monitor vital infrastructure such as bridges and the Port of Providence.

OSHEAN has used its training facility, which will be connected to the Beacon 2.0 Network, to provide training funded by the Governor's Comprehensive Workforce Improvement Grant. This grant has provided approximately \$40K in funding to train approximately 100 IT professionals.

Fit with BTOP CCI Priorities:

1 – Community Anchor Institutions

OSHEAN's core mission is to provide broadband access and equipment to CAIs. Today, through Beacon 1.0, OSHEAN connects 14 of its CAIs to dark fiber. Through Beacon 2.0, OSHEAN will provide new and substantially upgraded connections which will directly benefit the majority of Rhode Island's most important CAIs, as well as the hundreds of thousands of citizens served by them by. All partnering organizations have signed letters of commitment to fund their own connection to the Beacon 2.0 Network. In addition, Beacon 2.0 will pass by hundreds of additional CAIs such as libraries, health centers, labs, and more; that will now have access to affordable broadband connectivity.

2 – Public-Private Partnership



important institutions in the community. OSHEAN has worked closely with the RI State CIO and Broadband Stimulus Review Committee. We reached out to the Board of Higher Education and focused on identifying distance learning broadband needs of community colleges. In our collaboration with University of Rhode Island, the state's largest public university, we identified several areas where increases in bandwidth will support the research being conducted at URI and around the globe. We also worked with the Department of Transportation to plan how it will use fiber resources for their intelligent traffic management system.

As described in "Partners – Partners Description," the three main corporate partners that will assist OSHEAN in implementing the project include:



3 – Economically Distressed Areas

Rhode Island has the 3rd highest unemployment rate in the country at 12.9%. Bristol County in Massachusetts holds an unemployment rate of 12.2%. Five of the six counties served are classified as economically distressed areas according to Bureau of Economic Analysis and the Bureau of Labor Statistics. Due to budget deficits, programs are being cut, facilities are being shut down, and workers are being furloughed. Beacon 2.0 will deliver 364 job years. The Narragansett Indian tribe will utilize Beacon 2.0 advanced capacity to augment services in their new medical clinic, student computing center, and will also allow the tribal law office greater access to statewide resources as well as a direct connection to the RI State Police.

4 – Community Colleges

Beacon 2.0 will enhance distance learning programs at community colleges for career training of students including new campus at New England Institute of Technology and the Community College of Rhode Island (CCRI). At CCRI, we will bring dark fiber to the Warwick and Newport campuses (Newport campus is in the middle of a public/subsidized housing area). These institutions are all workhorses for reeducating and retraining displaced workers. They maintain an open admissions policy and affordable access for their 24,000 students, and cater especially to "non-traditional" students with diverse educational backgrounds. These institutions have seen a dramatic increase in the number of students taking online courses, increasing their demand for broadband capacity.

5 – Public Safety Entities

Beacon 2.0 will benefit several RI public safety entities including 2 State Police Barracks. It will support RI Emergency Management Agency and RI State Police 911 to facilitate the consolidation of the intelligent traffic management system control center. Fiber will also be pulled to the new state police headquarters, a campus that houses multiple public safety entities. There, Beacon 2.0 will provide a seamless communications infrastructure among the public safety agencies within RI. The project will also provide additional capacity for the RI Disaster Medical Assistance Team. Beacon 2.0 will enable the integration of Providence city and institutional security camera systems to increase visibility of police into university campuses and allow connection of cameras to monitor the Port of Providence.

6 – Last Mile Component

While Beacon 2.0 is a Middle Mile Project, OSHEAN is collaborating with several partners that commit to bring connectivity to last mile service areas some of which are underserved. They include:

- Taunton Municipal Light Plant (TMLP) portions of South Coast, MA
- Narragansett Indian Tribe Tribal lands in southern RI
- RINET K-12 schools and libraries throughout Rhode Island

Description of the involvement of the partners listed above in the project.

OSHEAN has conceived of and planned this project in close cooperation and collaboration with partners from government, important anchor institutions in the community, and private vendors. We submitted a preliminary proposal to the RI State CIO, Broadband Stimulus Review Committee in August 2009 for Beacon 2.0. Leading up to that proposal, OSHEAN worked diligently with the Chief Information Officer of Rhode Island, and provided numerous inputs to his Broadband Stimulus Review Committee. A common denominator in our discussions and collaboration with RI government organizations was that Beacon 2.0 would help them implement programs that they had already identified as necessary, and that would otherwise require state government money.

Beacon 2.0 is a partnership between OSHEAN, corporate partners, and 20 significant CAIs representing 50 institutional facilities that have committed funding, as evidenced by the attached letters of commitment.

OSHEAN (Applicant)

OSHEAN has spearheaded the project and is responsible for overseeing its implementation, operation of the Beacon 2.0 network, and financial management and administration. OSHEAN

maintains, operates and provisions a DWDM network using the Cisco 15454 Optical Platform. We lease dark fiber from commercial entities. OSHEAN holds SLAs with these entities to ensure any service disruptions are repaired quickly. The OSHEAN network operations center (NOC) is staffed 24 hours a day and 7 days a week. OSHEAN will make an in-kind contribution of \$214,201 for the recurring lease of existing fiber to be used with Beacon 2.0.

Anchor Institutions

These include 20 significant institutional partners and 50 facilities that will provide funding to connect to the Beacon 2.0 Middle Mile project and to maintain the network infrastructure within their own facilities. Total matching funding from CAIs includes \$2,477,383. As a standard, each CAI will match, at minimum, \$40,000 of the lateral cost required to construct a connection to each of their facilities. CAIs that lie more than one (1) mile from the backbone may provide a greater contribution. All institutional commitments and specific cash matches are confirmed in the attached letters of commitment.



Methodology used to estimate jobs:

As requested by the application guidance, OSHEAN referenced the Council of Economic Advisor's "Estimates of Job Creation from the American Recovery and Reinvestment Act of 2009" document to estimate job-years. Based on a project cost of approximately \$33.5 M, OSHEAN used the government standard denominator of \$92K to calculate 364 job-years. Direct/Indirect job-years were calculated by a factor of 64% and Induced job years as a factor of 36%. Finally, based on our own calculations for jobs based on our partner estimates, we the Direct/Indirect job-years were subdivided into individual estimates.

Project Impact:

Beacon 2.0 will have a wide scale effect on the CAIs that impact the broadest percentage of the population, including universities, community colleges, public libraries, health maintenance organizations, public safety, and government agencies. The Beacon 2.0 path will traverse all of RI's five counties and South Coast, Massachusetts. It will pass nearly 500 anchor institutions, over 349,000 households and approximately 8,100 businesses.

SUMMARY IMPACT

Education/Continuing Education/Workforce Retraining Impact
Immediate beneficiaries include 2 Community Colleges at 4 Locations, 10 university campuses, and 1 RI State Agency. Beacon 2.0 will allow for affordable broadband connectivity to the RI Division of Labor and Training and will meet the growing demand for distance learning programs at 2 of the state's most important institutions for career retraining of displaced workers: Community College of RI, and New England Institute of Technology. Beacon 2.0 will leverage the benefits of NEREN's research network at more colleges and universities and create supercomputing synergies between universities. Beacon 2.0 will create synergies with an awarded \$1.2M BTOP Round 1 grant to enable important broadband streamed services at 49

libraries at 70 locations, such as online job searches and applications.

Health Impact

Immediate beneficiaries include 15 hospital facilities and health centers. Others potential CAIs include nursing homes/long-term care facilities, doctor's offices, and clinics. Beacon 2.0 will pose great synergies with two other ARRA grants (\$11.28 M total) awarded to the RI Quality Institute (RIQI) for managing and transporting data-intensive medical files. Beacon 2.0 will make distance learning more accessible to medical professionals. It will enable affordable automated records management and transfer to/from community hospitals, long term care facilities, and doctors' offices.

Public Safety Impact

Immediate beneficiaries include 2 State Police barracks, 2 courthouses, and 5 security camera facilities in the City of Providence. The fiber will be installed at the new public safety campus which houses the State Police, Statewide E-911 PSAP, Intelligent Traffic Monitoring Center, RI EMA and Port Authority. Beacon 2.0 will provide a seamless communications infrastructure among these public safety agencies within RI. The project will also provide additional capacity for the RI Disaster Medical Assistance Team. Beacon 2.0 will connect cameras to monitor the Port of Providence.

Immediate beneficiaries include 13 government agencies. Beacon 2.0 will provide substantially upgraded broadband access to one of RI's largest government campuses of state agencies. The Dept. of Labor and Training (DLT) has grown progressively dependent on online correspondence as many Rhode Islanders seek employment assistance. With an unemployment rate nearing 13%, the DLT has been besieged with requests for unemployment benefits and has outpaced the department's staff ability to address process claims. Increasingly the DLT has turned to online resources to mitigate this overwhelming demand.

SPECIFIC IMPACT EXAMPLES

Online Learning at Community Colleges with an Emphasis on Workforce Retraining:

Unemployment rates in RI and nearby South Coast, MA exceed 12% and show no immediate sign of dropping. Beacon 2.0 will provide broadband access to two community colleges and will enable online learning for career re-training of displaced workers. With the displacement of workers, the state's community colleges are called upon to reeducate and retrain workers in growing and emerging fields such as allied health and green technologies. Examples include wind energy, smart grid and smart building technologies. The community college systems maintain an open admissions policy, affordable access, and especially cater to "non-traditional" students with diverse educational backgrounds. Online learning is a cost-effective option for many. Beacon 2.0 will provide for the affordable high-speed access that these institutions, several of which reside in economically depressed areas. Currently, 55% of students at community colleges are enrolled in online learning, a percentage that significantly increases annually.

Synergies with Ocean State Libraries (OSL) Grant awarded in Round 1:

OSHEAN was awarded a \$1.2M public computer center grant in BTOP Round 1. OSL will now set up permanent broadband workstations at all 49 of its member libraries plus state-of-the-art mobile computer centers, geographically dispersed and located in Rhode Island communities that are the most underserved and have higher rates of poverty. If this Beacon 2.0 Middle Mile project is awarded, OSL will be able to obtain significantly increased capacity. These centers will directly benefit both the neediest citizens and the library staff that is working to support them. Increased bandwidth will allow OSHEAN to deliver the online services that were intended

Synergies with Rhode Island's "Knowledge District":

The City of Providence is building a Knowledge District on 20+ acres of land within a revitalized section of the city which will serve as the epicenter for research-driven entrepreneurial activity. This initiative is critical to economic recovery and job creation. An important part of this project will be the construction of a statewide high performance data center. OSHEAN will create a critical fiber optic connection between the Knowledge District and major educational and healthcare institutions. This will allow collaboration among institutions for data-intensive research, such as the NIH \$20M Clinical and Translational Science Award. Beacon 2.0 will provide the infrastructure that no individual institution could afford.

Synergies with Statewide Public Safety Programs:

Beacon 2.0 will enable the affordable integration of several institutional security camera systems, including universities and hospitals, into the City of Providence's network so that police can monitor the campuses. Although sophisticated camera networks exist at several prominent Providence institutions such as Brown University, the city police are not connected, despite their overlapping jurisdictional responsibilities. A \$4.5M Homeland Security Grant will be leveraged to connect cameras to monitor vital infrastructure such as the Port of Providence. Beacon 2.0 will provide tremendous synergies that would otherwise require city/state funds which are unavailable.

OSHEAN's current network provides connectivity to five of the state's seven courthouses. Beacon 2.0 will leverage this existing infrastructure by connecting the remaining two courthouses, which is necessary to meet Chief Justice Suttle's goal of increasing usage of videoconferencing to all courthouses to cut costs of prisoner transportation.

The RI Quality Institute (RIQI) received \$11.28 million from two ARRA grants for health information technology. CurrentCare will expand the state's capacity for improving the quality of public health. It will allow medical records to follow the patient, providing clinicians immediate access to critical health care information and advanced research where and when treatment decisions are made. CurrentCare, whose data center currently resides on OSHEAN's network, has already enrolled 37,000 Rhode Islanders and deployed a pilot project. Unfortunately, some facilities do not have the broadband capacity necessary to participate, particularly those that cater to vulnerable populations. Beacon 2.0 will enable that participation.

Synergies with RINET

The K-12 schools and library statewide network, is managed and operated by the RI Network for Educational Technologies (RINET) which was one of OSHEAN's founding members in 1999. RINET utilizes a \$4M annual fund, collected through State surcharges and E-rate subsidies, to pay for leased circuits that connect 49 libraries and 350,000 students at 383 schools. In recent years the connectivity requirements of schools and library have outstripped the funds to satisfy the demand.

The ability for the dwindling funding pool to meet the school and library demand has been extremely difficult. As indicated in the FCC report "Connecting America: The National Broadband Plan," schools and libraries will need 1 GigE of connectivity in the future. Beacon 2.0 is the sustainable solution that will help make that happen.

Vulnerable Populations:

Beacon 2.0 will enable CAIs to close the "digital divide" by making substantially upgraded broadband access possible for those institutions that are key to serving RI's less affluent citizens, including community health centers, long term care facilities, public libraries, community colleges, RI Division of Labor and Training, and Narragansett Indian Tribe. Beacon 2.0 will enable online learning programs at the state's most important institutions for career re-training of displaced workers, Community College of Rhode Island, and New England Institute of Technology.

The Narragansett Indian Tribe provides health care and education programs for their 2,500 members. Located in rural Washington County, the tribal lands house a medical clinic and computer center for tutoring students, as well as their Law Enforcement offices and a community center. Beacon 2.0 will bring a direct fiber connection to these facilities to allow for reliable, high speed broadband to provide online access to resources needed to provide health care, education and public safety.

Vulnerability related to Education:

University endowments have dropped to record lows. Unaffordable broadband access has stalled state and regional cooperation among universities. Community colleges are overwhelmed in trying to train the state's unemployed/displaced workforce. All budgets are slashed with programs cancelled and staff downsized.

Vulnerability related to Healthcare:

In March 2010, 16% of Rhode Islanders were reported to be without health insurance. This is the highest level ever and has doubled since 2000. This has put a significant strain on the health care system and particularly community health centers which bear the burden of providing care for the uninsured.

Providence Community Health Centers (PCHC) is the largest primary health care provider in Providence, serving more than 35,000 patients, regardless of their ability to pay. Operating five health clinics, PCHC is the largest provider of the WIC nutrition program in Rhode Island, with 6,500 participants.

In order to accommodate the growing uninsured population and deliver cost effective health care, Beacon 2.0 will provide the substantially upgraded bandwidth required to integrate PCHC into the statewide HIE.

Vulnerability related to Libraries:

Libraries are forced to mitigate the "Digital Divide." They cater to displaced or otherwise career changing workers with services that help them get back into the workforce. As people lose jobs, families are canceling their home internet service and depend more heavily on the libraries to be

their internet resource, their community connection, and their place to learn. Rhode Island libraries are trying to survive difficult times.

Level of Need:

Rhode Island's anchor institutions in education, healthcare, and public safety have a tremendous unmet need for broadband capacity. OSHEAN's Beacon 2.0 Project will address these needs by leveraging existing available fiber assets and building new fiber to provide a sustainable advanced optical infrastructure needed by our State's anchor institutions today. Beacon 2.0 will also provide a "future-proof" infrastructure to support our institutions as they prepare our citizens for the jobs of the future.

Unmet Needs of our Anchor Institutions

Rhode Island has a competitive residential broadband market with two major providers serving most of the homes in the state. Our anchor institutions have some level of access to commercial broadband everywhere in Rhode Island. Unfortunately, the available broadband products do not meet their heavy bandwidth demands. These institutions need a minimum of 1GigE in order to communicate with each other, their constituents and the Internet at-large and several (e.g. Brown University, CCRI, URI, Lifespan) are seeking up to 10GigE for advanced applications. The cost for bandwidth capacity at these levels exceeds available budgeted funds.

Meeting the Need Where Access to Dark Fiber is Available

Six years ago, OSHEAN members committed to finding a solution to restrictions on bandwidth that the commercial market was creating. In response, OSHEAN sought out competitive dark fiber agreements to develop our Beacon 1.0 service. This fiber is now ready to support the 10GigE connections that some of our advanced members seek in this proposal, a testament to the fact that dark fiber solutions are extensible and scalable.

By leasing existing dark fiber from wholesale providers and operating our own optical equipment, OSHEAN is able to provide our members with cost effective 1GigE connections. The original Beacon 1.0 service saved our members over \$1.7 M in 2008 and again in 2009. Through our current Beacon 1.0 project, OSHEAN provides over 36GigE of connectivity to anchor institutions over dark fiber

Meeting the Need Where Access to Dark Fiber is Not Available

With Beacon 2.0, OSHEAN will install new fiber in areas where we are unable to lease dark fiber today. This includes Newport County, Bristol County, Washington County, and extreme western Kent & Providence counties in Rhode Island, and Bristol County in neighboring Massachusetts. All but Washington County have been defined as economically distressed by the Bureau of Economic Analysis and the Bureau of Labor Statistics.

OSHEAN experience indicates that those institutions without access to dark fiber are the most in need of a solution because they cannot afford the necessary level of bandwidth at commercial rates. Such institutions have difficulty participating in some of OSHEAN's services such as access to our Safe Harbor disaster recovery center and our Cumulus Cloud Computing Service in Providence and Springfield, MA. Our health care institutions are unable to easily transfer digital diagnostic images or PACS system data between facilities. We have clear evidence that dark fiber removes the bandwidth barriers our anchor institutions face by providing them with at least 1GigE capacity at a savings when compared to commercial access.

Examples of Need: Underserved Newport County, Rhode Island

Newport County is made up of two islands and a peninsula making it costly to provide fiber assets. There is no dark fiber available to Newport County, yet this county houses four of our anchor institutions including Salve Regina University, Newport Hospital, the U.S. Naval War College and one of the four campuses of the Community College of Rhode Island (CCRI). This campus of CCRI is a cornerstone of the revival of a portion of Newport that contains a large population of economically disadvantaged persons living in subsidized public housing. These students are now within walking distance of the college. Students at this CCRI campus participate in the nursing and allied health program, training workers for one of the growing industries in Rhode Island. This campus would benefit greatly from an increase in broadband that would allow for high definition video conferencing to collaborate with faculty at other CCRI sites on the mainland.

Bristol County, RI sits on a peninsula and is the home of two OSHEAN members, Bradley Hospital for Children, and Roger Williams University (RWU). RWU has engaged several providers in the county to seek access to dark fiber but has been unsuccessful in bringing fiber to its campus. RWU utilizes videoconferencing to collaborate with the marine studies programs at URI. RWU's School of Law has worked with the courts to videoconference courtroom hearings from Providence into the classroom. These efforts, however, can only be performed are stifled due to the RWU's limited broadband capacity. With Beacon 2.0, RWU seeks a 10GigE connection which would provide the opportunity to expand these programs.

Examples of Need: Underserved Washington County, Rhode Island

Washington County is the southernmost county in Rhode Island and houses anchor institutions such as three campuses of URI, Westerly Hospital, South County Hospital, Washington County Courthouse, the Narragansett Indian Tribe, and access to Block Island. This county is the furthest from Providence and has no access to dark fiber, forcing them to pay the highest rates in the state.

South County Hospital had to resort to building its own fiber link between two of its facilities in Washington County, at a cost of \$110,000 for less than a mile, in order to afford the 1GigE capacity that was desperately needed.

Westerly Hospital recently sought to create a fiber link between the main hospital and a clinic in nearby Connecticut, but the cost of the build was prohibitive. Beacon 2.0 will provide fiber that will reduce that cost.

The University of Rhode Island (URI), a land grant college, has three campuses located in Washington County. The main campus in Kingston is currently seeking a 10GigE connection to the OSHEAN network to obtain access to other research universities via Internet 2. This capacity is not available to them. The Graduate School of Oceanography is located at the Narragansett Bay Campus and is the home of the Innerspace Center, which uses advanced telepresence facilities to link researchers from around the country to ocean research ships at sea around the globe managing underwater robotic submarines. This telepresence facility brings live pictures from the sea floor and allows researchers on land to direct the pilots of the robots to certain areas of interest on the sea floor. The Innerspace Center is always challenged with obtaining adequate

bandwidth to carry the signal from a satellite landing station to the Narragansett Bay campus in RI. A dark fiber connection of 1GigE or 10 GigE would address this need.

URI is partnering with OSHEAN to build a fiber path for a portion of the connection to OSHEAN using NSF and NIH infrastructure grants. OSHEAN will leverage this \$1M of fiber for other members as well. URI plans to light its portion of fiber at 10GigE. To support URI's 10GigE, Beacon 2.0 will need to complete the fiber path to the OSHEAN network in Providence.

URI is also collaborating with several towns in Washington County and the Washington County Regional Planning Council to build a fiber optic network that will connect town CAIs to the university and each other. The university will leverage Federal funds to extend services to nearby towns. OSHEAN will provide expertise to URI to assist with this effort.

Narragansett, in Washington County, will be the landing site for our submarine fiber cable that will bring the only fiber connection to Block Island, which is located 10 miles off the Rhode Island coast. The first off shore wind farm on the east coast has been sited off the Block Island coast. Deepwater Wind is the private firm that will install this wind farm, and is installing a submarine power cable between Narragansett and Block Island. OSHEAN will partner with Deepwater Wind to leverage the cost of installing a power cable to include the first fiber optic cable to serve Block Island. The optical cable will be used to bring improved broadband capacity to the island residents, and will provide important monitoring capacity for the green energy wind farm project.

Example of Need: Underserved Bristol County, Massachusetts

OSHEAN is collaborating with Taunton Municipal Light Plant (TMLP) a century old government-owned utility that provides electric service, cable television, and telephony services to 34,000 customers in Southeastern Massachusetts. TMLP has implemented a pilot program to bring residential broadband service to 1,000 of its electric service customers. Utilizing Beacon 2.0 middle mile infrastructure, TMLP will provide last mile broadband service to homes and businesses throughout the South Coast Massachusetts. Additionally, TMLP is seeking to employ "Smart-Grid" technologies such as automated meter reading (AMR), load control, SCADA and network security. TMLP is also supporting public safety, Homeland Security, education and municipal network initiatives which would greatly benefit from Beacon 2.0.

Methodology for Area Status:

The two Beacon 2.0 Middle Mile Service areas (Rhode Island and South Coast, Massachusetts) are both "served" in the aggregated, despite the fact that several census block groups are underserved.

OSHEAN contracted with Broadband Consulting Group, Inc. (BBCGi) to conduct our analysis of census blocks passed by our Beacon 2.0 Middle Mile Program. BBCGI is a consortium of broadband technology, telecom, marketing, and IT specialists with significant experience in developing, building and marketing complex technologies for service providers.

BBCGi has constructed maps by census block group (CBG), as well as the geographic and demographic description of the Beacon 2.0 proposed funded service area. BBCGi uses a combination of proprietary network testing as well as existing provider knowledge to determine if a specific CBG or funding service area is unserved or underserved. BBCGi purchased current household records from Experian Marketing Solutions to obtain a representative sample of household addresses and demographics for individual Census Block Groups within each proposed funding service area.

To determine which CBGs were underserved, BBCGi used multiple criteria for determining underserved status:

Availability Test: BBCGi tested for availability of broadband for a sample of individual households within each CBG in the proposed Beacon 2.0 funding service area to determine the

percentage of households that did not have broadband available. The qualification threshold was <50% of the households with broadband access.

Advertising Test: BBCGi used its extensive history and expertise in developing and tracking market research for telecom and broadband service providers to determine if any broadband providers were advertising broadband service of at least 3 Mbps (downstream) in the proposed funding service area.

Adoption Test: BBCGi used proprietary sampling techniques, availability indicators, and demographic based adoption modeling to determine the rate of broadband subscribership for the proposed Beacon 2.0 funding service area. The qualification threshold was <40%.

BBCGi's sampling methodology for determining underserved areas included:

- 1) Processed active telephone numbers and corresponding addresses against public switched telephone number databases, cable and telephone franchise databases, individual provider broadband availability websites, and internal databases to determine both availability and penetration of broadband service for each household in the representative sample, and
- 2) Input all collected data into BBCGi's database to provide directly measured or modeled penetration estimates for the appropriate geography (CDC or area, depending on application).

Description of Network Openness:

OSHEAN understands that, as a precondition of award, the proposed project (Beacon 2.0) must be consistent with the FCC's non-discrimination and network interconnection obligations, specifically FCC's Broadband Policy Statement 05-151. Because OSHEAN offers broadband services as the integral component of our product offering, we maintain a network non-discrimination policy and will ensure that Beacon 2.0 abides by the policy. OSHEAN's policies on nondiscrimination, interconnection, and network management will be accessible on the OSHEAN Web site. If any changes to these policies are made the Web site will be updated and notification of such changes will be sent to our members.

OSHEAN provides Internet services to community anchor institutions in an open, non-discriminatory manner. Any OSHEAN member is eligible to connect at reasonable rates and terms. As part of this project OSHEAN will connect its members to several upstream Tier 1 service providers that provide full access to the public Internet. OSHEAN makes no distinction in its treatment of customer traffic based on application or content.

Interconnection Policy

Beacon 2.0 will provide interconnection points in the collocation facilities. These interconnection points allow ILEC, CLEC and other independent telecom companies to service the last-mile area with wholesale access at reasonable rates and terms to network components and services such as wavelengths and fibers, in accordance will OSHEAN Policies. OSHEAN also encourages settlement-free peering with all willing Internet service providers.

Network Management Policy

The OSHEAN Internet service is based on best-effort delivery. OSHEAN does not use any mechanisms to allocate bandwidth preferentially to any specific class of users, applications, providers, or sources. OSHEAN members, peers, and providers are limited only by the physical or contractual bandwidth limitations of their connection to the network. OSHEAN does not restrict user's access to specific content, block the use of specific applications, or limit the type of devices that can be used to access the network. OSHEAN will block any traffic destined for its infrastructure by unauthorized sources and will take the appropriate action to either block or limit traffic that transits its network if, the core technical team at OSHEAN determines, that traffic is harmful to the recipient. OSHEAN will cooperate with law enforcement if notified of harmful or illegal traffic transiting its network.

System Design:

The new OSHEAN Beacon 2.0 Network will extend the reach of the existing Beacon 1.0 network to middle mile CAIs using new physical fiber infrastructure. The proposal includes two service areas, Rhode Island and South Coast, Massachusetts. The Network design consists of four sections including, Physical Fiber Infrastructure, Optical Transport, Routing\Switching and Network Management.

Physical Fiber Infrastructure

The new physical infrastructure will support interconnection points spread throughout the service areas for CAIs. The fiber cable plant will consist of Single Mode Fiber which will meet or exceed the ITU-T G.652 Standard. The new cable plant will be constructed as 95% aerial and 5% underground for a total of 357 miles and passes through all five counties in RI and Bristol County MA. The new fiber consists of 48 strands dedicated to OSHEAN members. OSHEAN will hold a 20 year IRU on the 48 Strands with 20 years of renewal options. After analysis of bandwidth trends of our CAIs, we determined this fiber count to provide robust capacity for the future.

OSHEAN currently leases 2 strands of fiber from Providence to Boston, MA that will augment the new infrastructure. OSHEAN is a member of NEREN, which currently holds an IRU with Level 3 for a fiber ring from Providence to Hartford, Springfield, and Boston. Leveraging this existing NEREN fiber allows our members to interconnect with Open Cape, Northern Crossroads (NoX), TMLP, Internet 2, Cogent, Sprint, Level 3 and other providers. It will also allow our members connectivity to the OSHEAN disaster recovery and cloud computing site in Springfield, MA.

Optical Transport

OSHEAN will use DWDM Nodes, strategically located throughout RI and South Coast, MA, configured in a ring topology and installed in anchor institutions. Eight Node locations are Higher Education sites where existing building infrastructure such as HVAC and Protected Power can be leveraged. These nodes will serve as the connection points for other OSHEAN members in the node vicinity. All CAIs that are not in the vicinity of an Optical Node will be connected via dedicated fiber strands.

Some nodes will also serve as Interconnection points to other regional networks. Two of the Nodes (Boston and PVD AP3) will be augmented to allow interconnection between the NEREN

Optical network and the New Beacon 2.0 Optical Network. By leveraging the NEREN optical network OSHEAN will be able to provision 1GigE and 10GigE services to CAIs anywhere on either network.

Each Node is fully redundant, configured with the appropriate amplification and dispersion compensation to support 40 channels at 10GigE with a total capacity of 400GigE, scaleable to100GigE per channel and a total capacity of 4000GigE. Each node will be designed with a Reconfigurable Optical Add Drop Multiplexer (ROADM) card which transports 40 channels in the C band. These key optical components have been designed to scale to 100GigE per channel. This network will have a combination of 2 degree and multi-degree ROADMs. Services will be provisioned redundantly (East and West) on the New Beacon 2.0 network. Add/drop functionality can be provisioned on any lambda at any of the node locations

Routing and Switching

Each node will consist of a tunable 20GigE (10GigE East and 10GigE West) which supports twenty 1GigE client ports and can be equipped with GigE optical transceivers providing inexpensive connectivity to the backbone for anchor institutions. Each 1GigE client port can be provisioned to add/drop bandwidth at each node on the New Beacon 2.0 Network. The Xponder behaves like a layer 2 switch and supports many features of a layer 2 switch including, VLANs and QoS functions. The Xponder capabilities allow OSHEAN to provision bandwidth as needed without long term commitments, which is beneficial to R&E projects for collaboration between researchers.

The new Beacon 2.0 Network will have Optical Nodes at the OSHEAN Aggregation Points (PVD AP1, PVD AP2/RISD and Boston) The AP1 router serves as the connection to the Internet. The AP2 router serves at the connection to research and education networks such as the NoX and Internet2. The Boston router serves as a redundant connection to the Internet and the NoX. The NoX facilitates advanced networking among research institutions in New England.

Each member will receive the appropriate 1GigE or 10GigE router. If the existing member router is capable of supporting the new connection then only the interfaces will be provided to augment the router.

Network Management





OSHEAN's Community Anchor Institutions, OSHEAN has continuously found that leasable dark fiber does not exist outside of Rhode Island's Metro areas and the South Coast of Massachusetts. While OSHEAN has explored opportunities to build out its own dark fiber network to reach underserved areas, it has found that the project is neither scalable nor financially feasible without federal assistance.

OSHEAN is an established 10 year old organization with proven experience in dark fiber deployments and impeccable financial history with its long serving financial institution, Merrill Lynch. When investigating self-funding for the project, OSHEAN researched loan and line of credit options with the bank and found that while financing would be granted, OSHEAN was not able to independently sustain the payment schedule required for a \$22M note. With an annual operating budget just below \$4M, a loan 500% greater than annual operations is too great a financial risk to be undertaken by OSHEAN.

Prior to BTOP, only Community Anchor Institutions in close proximity to existing dark fiber were able to take advantage of the high capacity, low cost asset. Those that reside more than a few miles away from any dark fiber backbone were only left with the option to build connections at prohibitive rates. OSHEAN Community Anchor Institutions work directly with OSHEAN for collaborative technology projects, when working together reaps greater reward and lower cost than doing it alone. Prior to BTOP, individual members reached out to OSHEAN to seek out dark fiber opportunities for their campuses. However, even when pooling funds, OSHEAN and members were only able to secure funding for a fraction of the \$33.5M required. With budget cuts and endowment freezes, adequate funds are simply not available.

OSHEAN estimates the total project budget to be \$33.5M. OSHEAN is seeking a federal funds request of 66.05% (\$22M) and is providing a Cash Match of 31.09% (\$10.4M) and In Kind Match of 2.87%

(\$961K). The NPV analysis without BTOP funds amounts to -\$11M. We are seeking a federal contribution of \$22M which is significantly greater than the NPV analysis without BTOP. OSHEAN is depreciating \$4.4M of equipment and amortizing \$27M of fiber. To ensure sustainability, OSHEAN has developed a business model that establishes reasonable pricing models that will produce revenues to cover both operating and project expenses. We recognize that this project will be constructed over a three year period, during which the outlay of funds for capital will be substantial. In later years, as revenues grow, depreciation and amortization are significant non-operating expenses.



Customer Base

Within the proposed funded service area, OSHEAN's existing customer base and Community Anchor Institutions include the following:

Universities, Colleges, and 2 Community Colleges – Within the proposed funded service area, OSHEAN currently has fourteen member institutions which comprise one community college, one state college, two state universities, one naval war college and nine private colleges and universities.

Licenses, Regulatory Approvals and Agreements

OSHEAN hired an engineering consulting firm to conduct site surveys and to advise us on acquiring licenses and regulatory approvals required to implement and operate Beacon 2.0. Our partner Fibertech currently has pole attachment and conduit use agreements with Verizon and National Grid. In addition, they have a Certificate of Registration with the State of Rhode Island to transact business in the State as a Telecommunications provider. They have franchise agreements with the City of Providence and the City of Cranston. Our Environmental Engineer has performed due-diligence on our proposed route.
