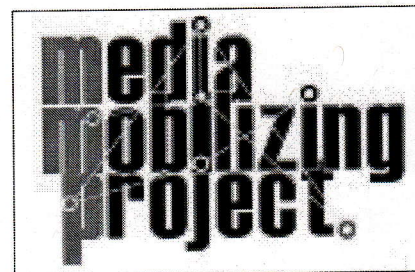

Media Mobilizing Project (MMP) is looking forward to participating in the *Freedom Rings Sustainable Broadband Adoption* project. Through this project MMP plans to instruct 720 participants per year for two years in intensive technology and multimedia skills. We believe this will provide Philadelphians with needed job and small-business development skills, directly impact at-risk high school students, non-English speaking immigrants, and increase the capacity of the network of social service, non-profit, and community organizations that serve them. Through this program we expect to create five full-time positions and seven part-time positions, building a path to economic recovery by developing the infrastructure necessary for Philadelphia to make a transition to the informational economy.

MMP's innovative program of digital inclusion through media production will train low-income workers and the unemployed, youth, non-English speaking immigrants, small business owners, non-profit and community organizations in not only the skills of getting online and accessing information – but becoming content creators themselves. Through video shooting and editing, including audio production, and basic web skills, MMP will train a team of media producers who can then communicate about their experiences with their own communities, building a feedback loop of community building.

This approach will extend the basic broadband adoption trainings and awareness campaign to create a community based core promoting the benefits of broadband adoption. The proficiencies learned in these trainings will assist in workforce development in a city where the population is woefully unprepared for a changing economy. The training will also directly serve small businesses, non-profits, and community organizations, providing them the training and resources needed to promote their services and keep their doors open in the 21st century economy. Educational and creative tools will be employed to encourage broadband adoption by youth, especially high school students who face a 50% drop out rate in Philadelphia Public Schools. Today's youth are often attracted to the internet first by social media, and Media Mobilizing



Project targets youth by offering training in audio and video production and web design, with the goal of supporting long term adoption by enmeshing the internet into their social and educational lives.

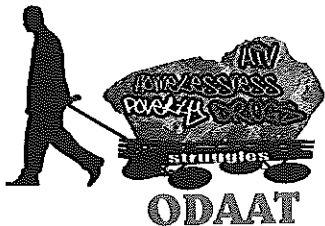



I am writing to express my strong, enthusiastic support for the Philadelphia Freedom Rings Broadband Adoption Proposal being submitted by the Greater Philadelphia Urban Action Coalition (GPUAC) for a Broadband Technology Opportunities Program grant under the American Recovery and Reinvestment Act (ARRA).

Philadelphia, one of the poorest cities in the country, is also one of its least wired, with 40% of its population with no Internet access at home. In order to create the most effective set of digital inclusion programs for Philadelphia, Philadelphia FIGHT has worked for the last year with GPUAC, the Media Mobilizing Project, People's Emergency Center, and dozens of other community groups to draft a proposal born out of the communities' own needs and wishes. The resulting multi-faceted proposal contains programs that engage thousands of offline Philadelphians in tested, community-based programs.

Philadelphia FIGHT is a comprehensive AIDS Service organization that offers a wide range of services to low income people at risk for acquiring HIV. It provides Internet access, email accounts, and website hosting through a homegrown ISP, the Critical Path Project, to over 12,000 Philadelphians. Connectivity has always been important for individuals living with or affected by HIV. Treatment information is readily available online but, more importantly, because treatment advances so rapidly in this field, print text is almost always outdated soon after it appears. For this reason since the mid-1990s, FIGHT began considering the implications of Internet access for our clients. The people we work with are for the most part individuals with low educational levels and minimal literacy skills. These are the very people often stuck on the wrong side of the digital divide. In addressing these issues, FIGHT has developed an extensive track record and competency in helping low income and disenfranchised people get online, and remain online using applications such as email and search engines to access health related information. Many have also gone on to use the Internet for other purposes to seek out information in ways that will be useful to them in rebuilding their lives.

Philadelphia FIGHT's experience implementing broadband adoption programs with community groups, such as Office of Supportive Housing shelters, recovery houses, other ASOs, and family centers, among others puts us in a position to immediately begin recruiting new participants and implement our training programs for new users on learning basic computer skills and finding life-saving health information. We are enthusiastic about the potential to expand and build on our existing initiatives, with

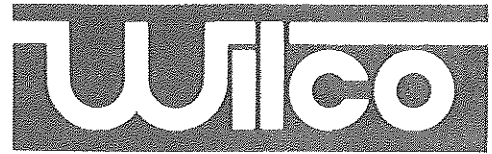



On behalf of the City of Philadelphia's Division of Technology, I am writing to express my strong support and enthusiasm for a significant proposal coming from the City for Sustainable Broadband Adoption. This proposal is called "Philadelphia Freedom Rings: A Sustainable Broadband Adoption Proposal" and provides an excellent model for the kind of community collaboration that we as a city hope for and strive to create.

In this case, however, the issue of digital inclusion is so critical to the success of our citizens that our partner organizations have cast any disparate politics and interests aside for the good of Philadelphia. That approach is to be commended, and I urge you to approve this proposal and demonstrate our government's commitment to the strength of our community organizations.
