# AMERICAN RECOVERY AND REINVESTMENT ACT STATE BROADBAND INITIATIVE SPECIAL AWARD CONDITIONS 78-50-M09055

The Recipient, the U.S. Virgin Islands Public Finance Authority (VIPFA), must satisfactorily address the following special award conditions by no later than October 3, 2011. Pursuant to 15 C.F.R. §24.43, Enforcement, failure to provide adequate documentation to NTIA and to the NIST Grants Office to support these conditions will result in the suspension of this award on October 14, 2011.

- 24. Accounting System Verification: The VIPFA, whether receiving Federal Funds or only providing matching funds, must have a functioning financial management system that meets the provisions of 15 C.F.R. § 14.21 and 15 C.F.R. § 24.20 to ensure proper accountability of funds. The VIPFA must submit an accounting system certification issued by an independent Certified Public Accountant (CPA) to the NIST Grants Officer by October 3, 2011. - 41. Mapping Data: The VIPFA must send to NTIA their current data submission as of August 29, 2011 for the data submission that would be due October 1, 2011 absent the stop work amendment. Under Special Award Condition #6 of the original grant award 78-50-M09055 U.S. Virgin Islands mapping and data collection activity is funded through December 31, 2011.
- 42. The VIPFA must submit an AAR that documents the increased match budget for ESRI software/hardware and non-Federal PFA funds to pay for Year 2 of data collection activities. The VIPFA must include information in the budget narrative that fully justifies these changes, including why the original contract appears to be over budget.
- 43. Project Plan: The VIPFA must submit a revised Detailed Project Plan (DPP), including timeline and cost estimates, to support the approved activity funded by 78-50-M09055. The VIPFA must conform to the terms of SAC 21 by September 30, 2011 including the submission for approval by the State Broadband Initiative of the required DPP, any Scope of Work (including cost estimates and contractor qualifications) for any contract in excess of \$100,000, and any job descriptions for new employees expected to be paid \$100,000 or more per year.
