6. Funding Clause:

The award period and budget(s) incorporated into this award cover a five (5) - year period and the budget sets forth a total Federal cost of \$8,682,670.00 in Federal funds. However, Federal funding approved and available at this time is limited to \$1,719,408.00 for the Recipient's broadband mapping activities and \$496,372.00 for broadband planning activities, for a total amount of \$2,215,780.00. The overall award period for this action will extend from November 1, 2009 through October 30, 2014. The funding period for this action will extend from November 1, 2009 through October 30, 2011 for broadband mapping activities and November 1, 2009 through October 30, 2014 for broadband planning activities, if any.
